# **Text Messaging Communication Opt In Form**

### **Program Description**

Safe Stop Insurance Agency offers its text messaging program whereby Safe Stop Insurance Agency, and any applicable service providers, will text message you to provide you with information concerning your account activity with Safe Stop Insurance Agency and other Safe Stop Insurance Agency products, services, and promotions (all of the foregoing the "Safe Stop Insurance Agency"). Safe Stop Insurance Agency and its service providers may, from time to time, use standard or an automatic telephone dialing system ("Autodialer") to deliver text messages to you under the Safe Stop Insurance Agency Program. You agree that you will not use the Safe Stop Insurance Agency Program for any illegal or unlawful purposes. No coverage may be bound or amended via text message or the Safe Stop Insurance Agency Program.

## **Message Frequency**

Under the Safe Stop Insurance Agency Program, the number of Safe Stop Insurance Agency text messages that you receive may vary depending upon your account activity and your communication with Safe Stop Insurance Agency.

# **Supported Carriers; Interruption**

The Safe Stop Insurance Agency Program should be available through your equipment or mobile device when the equipment or device is within the operating range of your wireless service provider. The Safe Stop Insurance Agency Program may not be available on all equipment/mobile devices, or through all wireless carriers, and not all functionalities of the Safe Stop Insurance Agency Program are available on all equipment/mobile devices, or through all wireless carriers. Safe Stop Insurance Agency may, from time to time, in its discretion and without notice to you, limit the carriers that support the Safe Stop Insurance Agency Program.
